

2020 FALL FUN WALK, RUN & ROLL RULES & REGULATIONS

ALL RULES MUST BE FOLLOWED. THE RACE DIRECTOR AND TIMING COMPANY RESERVE THE RIGHT TO DISQUALIFY ANYONE NOT FOLLOWING THE RULES.

- All runners are required to wear a mask/face covering before and after the race. Race staff and volunteers will wear masks at all times.
- Runners are encouraged to pick up their packets before race day. *Please visit_* <u>http://www.beautiful-people.us/</u> for pick-up location and up-to-date information. Race packet with runner's name will include a bib and long-sleeve t-shirt. Onsite check-in will be available on Race Day. Check-in lines will be marked at six-foot intervals.
- Hand sanitizer must be utilized in restrooms after use. Mask/face covering required. Six-foot spacing in waiting lines.
- Runners will start every 30 seconds, four or five at a time. Lowest bib numbers go first. Lines and runners will be six feet apart. *If you have immediate family members that live with you, up to five can start together.*
- Runners will be asked to adhere to a "no drafting" rule (i.e. runners must maintain a six-foot separation from other runners when passing.)
- Net chip time will be used to score, not guntime.
- Runners must leave the finish line area as soon as possible. No congregating in groups before or after the race. You must wear a mask/face covering after the race.
- Results will be available after the race, online only. No paper results will be printed. Visit www.SplitSecondRacing.net/results or results.
- Beautiful People reserves the right to cancel the in-person portion of this event at any point leading up to race day on Sunday, November 8th. All pre-registered runners who planned to race in-person will be asked to participate virtually if the in-person event must be canceled.
- The 2020 Beautiful People Fall Fun Walk, Run & Roll is not a sanctioned event, nor does it have Grand Prix status. Course is accurately measured.

2020 FALL FUN WALK, RUN & ROLL VIRTUAL RACE WAIVER

I know that running in an event that is organized as a virtual activity where I run on my own, at a date and time of my choosing, in a location and running route of my choosing, which will not have any support or security measures in place by Beautiful People is a potentially hazardous activity, which could result in injury or death. I acknowledge that I am participating in the activity outlined by this virtual event by my own free will and at my own personal risk. I will not participate in a virtual event unless I am medically able and properly trained, and by my signature, I certify that I am medically able to perform this event, and am in good health, and I am properly trained. I further agree to abide by the Center for Disease Control's (CDC) recommendations for the prevention of the spread of the 2019 Novel Coronavirus Disease (COVID-19) and other communicable diseases, and I attest to having read the CDC's guidance at: https://www.cdc.gov/coronavirus/2019-ncov/prepare/prevention.html. I attest that if my community has a shelter in place order, that I will only participate in the virtual event by using a personal treadmill, and I will not run outside in the community during the duration of a shelter in place order. I agree to follow all pedestrian safety ordinances including running on a sidewalk where available and not in the road. I agree to follow the rules of the road if no sidewalk or multi-use trail is available, and I will run against oncoming traffic and not with traffic.

I agree to abide by any decision of a race official relative to any aspect of my participation in this virtual event, including the right of any official to deny or suspend my participation for any reason whatsoever. I attest that I having read the rules of the virtual race scheduled for Sunday, October 25th-Sunday, November 8th, including the terms in this waiver, the timeline of the virtual event, and agree to abide by them. I assume all risks to me associated with running on my own as part of this virtual activity, including but not limited to: falls, contact with other pedestrians, the effects of the weather, including high heat and/or humidity, traffic and the conditions of the road or trail, all such risks being known or unknown and appreciated by me when out running on my own without any type of support from local officials or event organizers.

Having read this waiver and knowing these facts and in consideration of your accepting my entry, I, for myself and anyone entitled to act on my behalf, waive and release the Beautiful People Fall Fun Walk, Run & Roll and the Town of Warwick, all event sponsors, their representatives and successors from all claims or liabilities of any kind arising out of my participation in this virtual event, and waive my ability to bring any legal action against the entities outlined in this waiver as I am voluntarily electing to run on my own as part of this virtual event. I grant permission to all of the foregoing to use my photographs which I may share online as part of the event, personal data provided during registration and post-event reporting, video or audio recordings, or any other record of this event for any legitimate purpose. I understand that this event does not provide for refunds in the event of a cancellation, and by signing this waiver, I consent that I am not entitled to a refund if the event is cancelled before or during the event.

I assume all such risks being known, appreciated, and accepted by me.

Having read this waiver and knowing these facts and in consideration of your accepting my entry, I, for myself and anyone entitled to act on my behalf, waive and release The Beautiful People Fall Fun Walk, Run & Roll, the Hudson Sports Complex, the Town of Warwick, their staff, officers, volunteers, successors and assigns, all event sponsors, their representatives and successors from all claims or liabilities of any kind arising out of my participation in this event, even though that liability may arise out of negligence or carelessness on the part of the persons named in this waiver. In addition, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I may be exposed to or infected by COVID-19 by participating in this event. I acknowledge that such exposure or infection may result in personal injury, illness, permanent disability, and/or death.
